

## FIFA PRO BONO COUNSEL

As publicised within our Circular no. 1691 dated 2 September 2019, during its meeting in Paris on 3 June 2019, the FIFA Council approved the 2019 edition of the FIFA Disciplinary Code (FDC) and some amendments to the FIFA Code of Ethics (FCE), which both included the implementation of legal aid and access to pro bono counsel for individuals facing financial difficulties.

The implementation of such legal aid and pro bono counsel being an example of FIFA's commitment to guaranteeing the rights of individuals who lack the financial means to defend themselves properly at judicial proceedings before the Disciplinary Committee, the Appeals Committee and the Ethics Committee.

Following a selection process, the below individuals for the pro bono counsel positions have been chosen by FIFA. They will be required to act in accordance with the highest standards of integrity and honesty at all times in the performance of their duties in alignment with FIFA's vision.
